Nuveen Natural Capital managed Timberlands in **Tillamook County** will continue to be open for **Non-Motorized** Access only.

For timberlands in **Clatsop County**, beginning Thursday, October 27, thru Friday, November 25, 2022, the selected gates listed below will be open for vehicular access. Public access is welcome from one hour before sunrise until one hour after sunset. Do not block or park too close to the gates or your vehicle could be towed at your expense.
